ABSTRACT

The 1986-87 CLG Project for the City of Anadarko uses the 1983 Inventory as its review base in developing Inventory Files for the City's most significant buildings and structures.

The 1986-87 Project also included National Register Nominations for three individual properties, one multiple property, and a revised Downtown Historic District nomination; a Re-Use Study was completed for St. Patrick's Indian Mission, a 1939 film of Anadarko was stabilized and duplicated on videotape, and several Municipal publications were re-printed.

The 1986-87 Inventory produced 150 Inventory forms; these were placed in tabbed folders and provided to the Oklahoma Historical Society. This Report contains an annotated list of these 150 properties.

Additional recommendations were made for National Register and CLGF work.

Introduction

In 1983, the City of Anadarko was the subject of an extensive resource protection and planning project (RP-3) that resulted in preparation and adoption of a six-volume Preservation Plan series; ultimately, this was followed by formation of a Preservation Review Commission, adoption of a Comprehensive Preservation Ordinance and qualification as the State of Oklahoma's second participant in the Certified Local Governments (CLG) program.


The City's first project funded by CLG funds involved an intensive survey of Randlett Park on the west side of Anadarko. As a result of the Survey, fifteen properties were documented in the Park area.

This is the City's second CLG-funded effort, and it has attempted to cover a substantial amount of territory. The overall project involved the following objectives:

- A. Upgrading the existing (1983) Survey/Inventory to include preparation of survey forms and individual folders (150 were prepared);
- B. Preparing nominations to the National Register of Historic Places for the Municipal Swimming Pool, the C.L. Cleveland House, the C.R.I. and P. Railroad Depot, and the St. Patrick's Indian Mission Complex, and revising the pending nomination for the Downtown;
- C. Preparing a Re-Use Study for the St. Patrick's Indian Mission Complex;
- D. Reprinting of two earlier publications: the <u>Central Business District</u> <u>Economic Profile</u>, and the <u>Design Guidelines</u>; and
- E. Stabilizing and duplicating (on videotape) six reels of 1939 film (16mm) shot in Anadarko.

The area surveyed included the entire city limits of Anadarko (see map), with a renewed focus on the area covered by the 1930 Sanborn Insurance Maps.

Research Design

Since the first complete Inventory in 1983, the City and local groups have continued to collect data on historic structures in the community. The primary goal of the 1986-87 CLG Project was not to completely re-do the 1983 Inventory, but to utilize the Inventory as the <u>basis</u> for a more selective review of Anadarko's historic and architectural resources. To this end, the research design involved:

- A. Selecting the most significant buildings from among the more than 700 identified in the 1983 Inventory as built before 1930;
- B. Collecting data relating to those buildings selected;
- C. Re-photographing the most significant buildings;
- D. Preparing an (OHS) Survey Form for each building; and
- E. "Assembling all the available data on each building in a tabbed folder.

Sampling Strategy

The 1983 Inventory utilized a four-level hierarchy of significance to rate each of the 700-plus buildings inventoried. Basically, this rating system represented an elaboration of the "contributing" and "non-contributing" classifications, with "contributing" buildings further described as having:

- A. Major Individual Significance (Category I);
- B. Minor Individual Significance, with most buildings in this category typed as contributing to a potential Historic District (Category II); or
- C. Potential Significance, currently covered or obscured by reversible additions (Category III).

In determining which of the 700-plus buildings to review for the 1986-87 re-Survey, the Project Consultant used a two-part guideline:

- A. Category I buildings were reviewed on a 100% basis (to check their condition, existence, etc.);
- B. Buildings listed in Categories II and III were checked primarily to ensure withat no errors were made in the 1983 Inventory, and that a building's status had not changed; unless there had been such a change, Category II and III buildings were not generally included in the 1986-87 Re-Survey/Inventory.

Identified Resources

Using the design, strategies and guidelines discussed above, the Re-Survey produced 1986-87 Inventory Forms for 150 properties in the Anadarko, Oklahoma, City Limits. The following annotated list identifies each property, first by 1986-87 Inventory Number, then by County, City, Address or Location, Brief description, and former Inventory number from the 1983 Document.

These properties represent Central Business District, Turn-of-the-Century Commercial Buildings, a wide variety of Residential styles, several Churches, a Railroad Depot, the Fairgrounds Grandstands, and two buildings remaining from the former St. Patrick's Indian Mission School. The City's historic resources are scattered throughout the community in such a way that virtually no area is without historic potential.

Potential National Register Sites and Areas

The current project involves work relating to three (3) individual nominations, one (1) multiple properties nomination, and one (1) District nomination. Outside of these areas, there appears to be potential for residential district development to the west and east of the Downtown. More research is needed to identify houses re-located from "Old Town" and the Indian Agency in the late 1890's. The City's WPA structures should be considered for National Register nomination as soon as possible, as should the Municipal Hydro-electric Power Plant and Dam on the Washita River.

A bibliography of reference materials gathered during this project is included at the end of this report.

Recommendations

The Project Consultant has worked extensively with the City in the development of its preservation planning process, and to date, one continuing need remains high on the priority list: local information/photos relating to individual residential properties. The process appears to be establishing some momentum and this should produce increased accessibility to local resource materials. In the meantime, this remains a difficult and time-consuming problem to overcome.

Apart from the development of a local research continuum, there is now a mechanism to locally computerize the Inventory data, and this should be integrated into a future CLGF project. The computer resources will be acquired by the Municipal Library and utilized as a part of its Preservation Resources Center (also supported by CLG funds).

The Re-Survey also developed some indications that area Tribes on the fringes of Anadarko have become interested in the Preservation process; it is recommended that the City pursue this opportunity for further coordination in the protection of local historic, architectural and archeological resources.

Summary Statement

The 1986-87 (CLGF) Project attempted to provide a refined set of significant buildings in Anadarko for the development of OHS-approved data files; 150 such files were developed. The project also included National Register nomination for the most significant properties in the community, as well as a revised version of the Downtown Nomination, restoration and duplication of an historic 1939 film, preparation of a Re-Use Study to encourage restoration of the two buildings at the St. Patrick's Indian Mission, and re-publication of two previously-completed documents.
