BIG CABIN GYMNASIUM

The Big Cabin Gym is a rectangular shaped $(76' \times 54')$ structure with a single wing on the front facade. It is constructed from uncut and randomly laid native stone. The roof is gabled with projecting eaves over the central gym unit and an additional gabled roof, connected to the front facade, covers the wing. Windows have been altered with concrete block inlays and smaller energy efficient windows installed. All windows have cut stone sills. Pilasters decorate the sides of the gym. Additions to one side and the rear of the building in addition to the window alterations have destroyed the integrity of this building .

SIGNIFICANCE: 1939; builder/architect: unknown

This Gym is significant because it constituted an economically important community resource. Its construction provided 24,000 man-hours of wages for local families which were infused back into the depressed local economy. Jobs generated by the construction of the Gym restored a sense of pride to many men who might otherwise have been unable to provide for their families. Architecturally the gym is significant for its gabled roof design which is somewhat unique among WPA constructed Gyms in Oklahoma.

BLUEJACKET SCHOOL CAMPUS (Two buildings)

The Bluejacket campus contains two WPA constructed buildings (a third was destroyed during the 1985-86 school year). The main classroom building is is a rectangular shaped (170' x 63') structure constructed of crudely cut and slightly rusticated native stone randomly laid. The roof is flat and has parapets topped with concrete caps. The portion of the front facade upon which the main entry is found protrudes from the front of the building. The double-door entry is recessed within the protrusion and topped by a stepped cornice. The metal encased windows are grouped in pairs with concrete sills.

The second classroom building is situated southeast of the main building. rectangular (91' x 56') and constructed of uncut native stone randomly laid with extended mortar masonry. The flat roof has parapets with concrete caping. Two vestibule-like stone entries having double-doors and a concrete frieze over them are located on the front facade of the structure. The windows are metal encased and grouped into pairs. All windows have concrete sills. A small addition to the rear of the structure has not destroyed its integrity.

SIGNIFICANCE: 1936-1940; architect/builder: unknown

The construction on the Bluejacket campus constituted a tremendous community resource. Some 85,000 manhours of labor went into the construction of these buildings as well as others recently destroyed. The wages earned by the laborers were infused back into the local economy thus stimulating economic growth and easing the problems generated by the limited money supply. For many of the men these wages were the only means by which they Architecturally the buildings are significant for their fine could feed their families. workmanship and large scale.

The Ketchum school campus contains two WPA built structures: A main classroom building and a Gymnasium. The main classroom building is an "L" shaped structure (80' x 78'along the exterior walls) constructed from rusticated random ashlar masonry. It has a flat roof with parapets capped with concrete blocks. The front entryway consists of double doors with sidelights and transcoms. The entry is recessed, framed by pilasters and covered by a curved, preformed concrete awning which gives the structure allusions to modernesque form. The metal sash windows are grouped in triples with concrete sills and continous stone lintels. There is an inscribed concrete inset above the front entry.

The Gymnasium is a rectangular building (92' x 49') constructed of randomly laid, uncut native stone. The gym has a stepped gabled roof. Windows on the gym have been filled with wood insets; awnings cover the windows on the classroom section of this complex. Pilasters frame the windows on this structure. Additions to both structures destroy their integrity and disqualify them for inclusion to the National Register.

SIGNIFICANCE: 1939; architect/builder: Koberling & Fleming

This school is significant because it constituted an economically important community resource. Its construction provided wages for local families (for some 31,000 man hours of labor) which were infused back into the depressed local economy. Jobs generated by the construction of the school restored a sense of pride to many men who might otherwise have been unable to provide for their families. The school served for many years as an educational facility for children of the community. The structures are also significant for their vernacular style which alludes to modernesque style on the main classroom building.

This square shaped (34' x 34') single story building with sublevel is constructed of uncut, randomly laid native stone with beaded mortar. The roof is gabled with projecting eaves. The front entryway is recessed behind a portico which serves as a vestibule. Double-hung wooden sash windows are singly placed with concrete sills. Hopper windows serve to illuminate the sublevel. There is a concrete belt course which separates the sublevel from the rest of the facade. A wooden annex has been built onto the building's east side which destroys its integrity.

SIGNIFICANCE: 1940; builder/architect: unknown

This school is significant because it constituted an economically important community resource. Its construction provided wages for some 13,200 man-hours of labor for local families which were infused back into the depressed local economy. Jobs generated by the construction of the school restored a sense of pride to many men who might otherwise have been unable to provide for their families. The school served for many years as an educational facility for children of the community. This structure is unique for its sublevel design, indeed it may be the only one of its kind in Oklahoma.

The Russell Creek School is a rectangular $(35' \times 70')$ building with random ashlar masonry. It has a hipped roof and the double-door front entryway is framed by pilasters with a concrete lintel topped with a pointed cornice capped with concrete. The steel casement windows are singly placed in front and grouped into bands on the rear facade of the structure. All have concrete sills and wide concrete lintels.

SIGNIFICANCE: 1937; builder/architect: unknown

The construction of this school in a remote rural area of northeastern Oklahoma is significant in that it characterizes the WPA's commitment to the future of this country by providing educational facilities, even one room schools, for rural children as well as urban children. The construction of this school provided employment for men suffering the effects of the depression and infused wages from some 6200 man-hours of labor into the economy of the local community. For many of the workers the wages earned through the WPA were the only source of income available to them at that time. The work maintained their pride and saved them the shame of not being able to provide for their families. Architecturally the structure is unique for its austere style and lack of ornamentation.

This rectangular shaped (105' x 80') building is constructed of rusticated randomly laid native stone. The flat roof has parapets and stepped cornices over the entryways. The parapets are topped with concrete coping. The main entryway consists of double-glass doors with a hood and a concrete inscription which reads "Craig County Courthouse Annex." Covered now by a wood lattice work, the elongated windows are framed by pilasters and have concrete sills and lintels. There is a concrete motif above each window. A concrete block addition to the south side of the building has impaired its integrity.

SIGNIFICANCE: 1941; builder/architect: unknown

This structure is significant for its venacular design which incorporates elongated windows framed by pilasters with concrete sills and lintels, stepped cornices, and concrete inlays. It has economic significance as well in that the wages (for some 60,000 man hours of labor) earned from its construction were infused back into the community helping to stimulate the depressed economy. Employment on this project constituted for many men the only means whereby they could feed their families.

The Will Rogers High School gymnasium is a two level, rectangular shaped (104' x 79') building constructed from buff colored brick. It has a high arched roof with stepped parapets. Double door entries access the building. Windows consist of elongated, singly placed casement windows with brick sills and arched lintels and half-sized singly placed windows with brick sills and arched lintels. Pilasters with preformed concrete caps frame each pair of singly placed windows. Brick quoins on the corners, and raised brickwork friezes add decorative relief to the structure. Reduction in the size of the front entryways has not impeached the essential integrity of the building.

SIGNIFICANCE: 1940; builder/architect: unknown

Along with two NYA constructed buildings on the campus of Will Rogers High School, a project of this size constituted a tremendous resource for the community of Vinita. The wages from the more than 100,000 man-hours of labor that went into the buildings were infused back into local businesses and thus stimulated economic recovery. It is significant that brick building materials were utilized in the construction. The gymnasium provided a modern facility for educating the children and fostered a sense of pride within the community that their children would experience better conditions than their parents.

The White Oak gymnasium is a rectangular (100' x 55') addition to a pre-existing school building constructed of brick which has been painted white. The roof is arched with stepped parapets. The main entryway is recessed and framed by pilasters; the latter decorates the side of the gym as well. Window openings have been filled with wood inserts; their concrete sills have been painted red. Additions on the rear and side of the gym have pretty much destroyed the integrity of this building.

SIGNIFICANCE: 1942; builder/architect: unknown

The White Oak gymnasium is significant for its brick building materials. Most WPA structures in northeastern Oklahoma were constructed from native stone. Equally significant is the wages from some 32,000 man hours of labor that construction of the buildings brought to the community. In many cases the WPA wages were the sole means of income for depression stricken men. As these wages were spent locally they stimulated the economy and helped ease the burdens of a limited money supply. The school still serves as an economic resource for the community as teachers salaries and workers wages are infused back into the local business community.
