

MEMORANDUM OF AGREEMENT

SUBMITTED TO THE ADVISORY COUNCIL ON HISTORIC PRESERVATION

PURSUANT TO 36 CFR 800.6(a)

WHEREAS, the Department of the Army (Army) has determined that the abatement of asbestos and subsequent exterior reconstruction will have an effect upon Building 5037 at Fort Sill, Oklahoma, a property eligible for inclusion in the National Register of Historic Places, and has consulted with the Oklahoma State Historic Preservation Officer (SHPO) pursuant to 36 CFR Part 800, regulations implementing Section 106 of the National Historic Preservation Act (16 U.S.C. 470f);

NOW, THEREFORE, the Army and the Oklahoma SHPO agree that the undertaking shall be implemented in accordance with the following stipulations in order to take into account the effect of the undertaking on historic properties.

Stipulations

The Army will ensure that the following measures are carried out:

1) All abatement, modification, and reconstruction procedures will adhere to the specifications and drawings contained in the Fort Sill contract document "Abate Asbestos, Building 5037, Specification Serial No. DABT39-91-B-0029," with modifications, attached hereto as Appendix A.

2) A copy of the complete set of as-built construction drawings of Building 5037 will be provided to the Oklahoma SHPO. A second complete set of as-built construction drawings will be curated at the Fort Sill Museum.

3) Photographic documentation of the existing condition of Building 5037 will be undertaken. This documentation will be conducted using a 120mm camera and Tri-X black and white film. Negatives and photographs produced as part of this documentation will be archivally processed in accordance with the document "Photographic Specifications for Historic American Buildings Survey (HABS)/Historic American Engineering Record (HAER)," attached hereto as Appendix B. Eight by ten inch copies of all photographic documentation will be provided to the Oklahoma SHPO and Fort Sill Museum, and all photographic negatives will be curated at the Fort Sill Museum.

4) A historic narrative discussing the construction and use of Building 5037 will be developed by Fort Sill as part of the documentation process. This document will address the original and subsequent use of the building as well as identify modifications and changes of exterior and interior building elements over time.

Execution of this Memorandum of Agreement by the Army and the Oklahoma SHPO, its subsequent acceptance by the Advisory Council on Historic Preservation (Council), and implementation of its terms, evidence that the Army has afforded the Council an opportunity to comment on the asbestos abatement and exterior reconstruction of Building 5037, Fort Sill, Oklahoma, and its effect on historic properties, and that the Army has taken into account the effects of the undertaking on historic properties.
