MEMORANDUM OF AGREEMENT  
SUBMITTED TO THE ADVISORY COUNCIL ON HISTORIC PRESERVATION  
PURSUANT TO 36 CFR §.800.6(a)

WHEREAS, the U.S. Department of Housing and Urban Development (DHUD) and the Town of Wanette have determined that Project #5355 CDBG 91/92 will have an adverse effect upon the building at 115-117 N. Clarady, Wanette, a property eligible for inclusion in the National Register of Historic Places, and have consulted with the Oklahoma State Historic Preservation Officer (SHPO) pursuant to 36 CFR Part 800, regulations implementing Section 106 of the National Historic Preservation Act (16U.S.C. 470F),

NOW, THEREFORE, DHUD and the Town of Wanette will ensure that the following measures are carried out:

Prior to demolition, the building at 115-117 N. Clarady, Wanette, will be documented in accordance with the general requirements of Level II documentation as detailed in the "Secretary of the Interior's Standards for Architectural and Engineering Documentation" so there will be a permanent record of its present appearance and history. This will include the following:

1. large format photographs and negatives of exterior views and architectural details; and
2. preparation of a written narrative history and description of the building.


All documentation will be edited, catalogued, and packaged in a manner acceptable to the Oklahoma SHPO, and must be approved by the Oklahoma SHPO prior to demolition of the building.

Execution of this Memorandum of Agreement by DHUD, the Town of Wanette, and the Oklahoma SHPO, its subsequent acceptance by the Council, and implementation of its terms, evidence that DHUD and the Town of Wanette have afforded the Council an opportunity to comment on the referenced CDBG project and its effects on historic properties, and that DHUD and the Town of Wanette have taken into account the effects of the undertaking on historic properties.




